### **VÆSENTLIGE BEGIVENHEDER (FORTSAT):**

Lægemiddelstyrelsen har (igen) uden varsel fraveget et tidligere givet tilsagn om, hvorledes medicindonationer kan foretages - en accepteret donation på 13 paller medicin for patienter med nedsat nyrefunktion måtte som følge heraf annulleres. Det er foreningens opfattelse, at Lægemiddelstyrelsens manglende accept af foreningens hidtil godkendte måde at donere medicin på, ikke er lovmedholdelig og foreningen har derfor til hensigt at indbringe Lægemiddelstyrelsens afgørelse for Sundhedsministeriet.

En rejse til Burundi i februar 2023 var fuldstændig mislykket, idet den tidligere ombudsmand, som besøgte GMA i efteråret 2022, intet havde forberedt - hverken møder med Præsidenten, First Lady, ministre eller hospitaler. Det forlyder imidlertid, at First Lady i løbet af kort tid vil fremsende en invitation.

Som det fremgår af ovenstående var I. halvår 2023 snarere præget af konsolidering end større aktivitet.

## Warehouse overflowing! Only two donations Again problems with medicine donations!

Total amount of medicine and equipment valued at DKK 292.868.682 (44,919,021.45 USD) donated since beginning in 2010

### MEDICINE AND EQUIPMENT:

**India:** two containers for private hospital

### FINANCES:

The economy is still under pressure despite the few donations, as the increasing donations of equipment from Funen and Jutland lead to increased costs for collection.

It is expected that donations abroad will increase significantly, which will lead to growing expenses. Likewise, the number of inspection trips will increase and lead to greater expenses.

### NOTEWORTHY EVENTS:

The warehouse is now maintained regularly and the equipment list is updated, which gives a good overview, facilitates the packing of the containers and provides a basis for better communication with the recipients, so that they receive to a greater extent what they need.

The Danish Medicines Agency has (again) without notice deviated from a previously given commitment regarding how medicine donations can be made - an accepted donation of 13 pallets of medicine for patients with reduced kidney function had to be canceled as a result. It is the association's opinion that the Danish Medicines Agency's failure to accept the association's previously approved method of donating medicine is not legally permissible and the association therefore intends to bring the Danish Medicines Agency's decision before the Ministry of Health.

## **NOTEWORTHY EVENTS (continued):**

A trip to Burundi in February 2023 was a complete failure as the former ombudsman who visited GMA in the fall of 2022 had nothing prepared, neither meetings with the President, First Lady, ministers nor hospitals. It is reported, however, that in a short time the First Lady will send an invitation.

As can be seen from the above, the first half of the year 2023 was characterized by consolidation rather than greater activity.
